1. Proof of registration with Pakistan Engineering Council (PEC) in C6 Category, duly renewed for the current year. (2) Proof of registration with Khyber Pakhtunkhwa revenue Authority (Active Tax payer list) under Finance Act, 2013 Act No. XXI of 2013. (3) Photo copy of CNIC. (4) Affidavits on declaration of no default/blacklisted or involved in litigation with the department. (5) Complete bidding documents-duly signed.

GENERAL TERMS AND CONDITIONS

3. Bid Solicitation Documents and Instructions to Bidders can be obtained from the office on any working day or downloaded from the department website www.few.kp.gov.pk before the submission date/time.
4. Bids shall be submitted separately for each package.
5. The bidders should submit their E-bids as per KPPRA Notification No. SOR (34)/Vol:1-45/2025-26 dated 27.08.2025.
6. In case of more than 10% below bids, if the bid is not accompanied by the detailed rate analysis and/or required of additional security, then the said bid will be dealt as per KPPRA Notification S.R. O (14) / Vol: I 24/2021-22 dated 10/05/2022.
7. In case detailed rate analysis submitted with the bids is, in view of the procuring Entity not convincing, the head of procuring Entity may declare such bid as non-responsive.
8. All bidders shall enter the details of the bid security and, where applicable, the additional security instrument in the EPADS at the time of bid submission. The original bid security and additional security instrument, the detail of which have already been entered in EPADS, shall be submitted well before the closing date and time of the bid submission.
9. In cases of amongst the successful bidding, winner will be decided based on toss on the presence of all the bidders.
10. Bid not fulfilling any of the criteria as stated above will be declared non-responsive.
11. All federal/Provinces/Stamp duties/Taxes will be recovered as per directions of the Government issued from time to time.
12. Electronic bids will be displayed by online E-Bidding system after 30-Minutes of closing time in presence of bidders/their representative.
13. The Competent authority reserves the right to reject any of all the tenders by assigning the cogent reason.
14. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
15. Venue of bids opening is the office of the Divisional Forest Officer Buner at Daggar.
16. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013, for the works, consulting and non-consulting services as listed in Schedule-11 of the Act ibid).
